Notice House Rules for KBGC Lawn Bowling Greens


This 'Notice' serves to inform KBGC Members of **AMENDED** 'House Rules' governing KBGC Lawn Bowling Greens as formally Minuted at the General Committee Meeting held on Friday, 23rd June 2017.

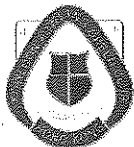
1) All Club 'In-House' Games / Competitions

- If a Green has been assigned for 'In-House' games / competitions, all participating players are prohibited from practising on the said Green on the day of the games / competitions.
- The Bowls Convenor / Assistant Bowls Convenor will conduct an investigation into any violation(s). If confirmed, the violator(s) may face disqualification from the games / competitions.
- Any violation(s) will be reported to the General Committee who may direct that a 'Written Warning' be issued to the violator(s).

2) All Bowling Events Organised by the Hong Kong Lawn Bowls Association (HKLBA)

- KBGC Members playing for opposition teams against our club are prohibited from either practising or competing on the "Green Concerned" within **SIX** days of scheduled HKLBA games / competitions. To avoid any misunderstanding this six days means the Monday to Saturday prior to the Saturday afternoon game inclusive. In the event of a rescheduled game, it means the six days prior to and the rescheduled game date inclusive. Also to be clear, the "Green Concerned" means the green on which our home team will play. If they are playing on Green 'A', the members representing another club can use Green 'B' for practice or Club games, or National games, but cannot use Green 'A', or in reverse depending on which green our team uses. For Rescheduled Games, we may not know in advance which Green will be used, therefore that will be subject to the Opening Schedules of the two Greens based on their conditions.
- If a member is found to be in breach of the above rule, the case will be referred to the General Committee.
- Should there be repeated violation(s) to the foregoing House Rules; the General Committee will have the right to 'Temporarily Suspend' the violator(s) from use of the Club's Lawn Bowling Greens for a determinate period.

通告 草地滾球場地使用守則

謹此通告各位會員，執委會於 2017 年 6 月 23 日（星期五）舉行的會議正式修訂草地滾球場地使用守則及將之納入會議記錄。

1) 所有本會內部賽事

- 本會草地滾球場如被編排用作會賽/比賽場地，有關參賽雙方球員均不能在會賽/比賽當天在該草場進行練習。
- 滾球事務委員/助理滾球事務委員會調查違規事件。核實後，違規者可能會被取消該項賽事的參賽資格。
- 執委會在收到違規事件報告後，可向違規者發出書面警告。

2) 所有香港草地滾球總會舉辦的賽事

- 在香港草地滾球總會舉辦的賽事中，代表外隊與本會球員對壘的本會會員，在比賽期間的六天內，禁止在本會“有關草場”進行練習或競賽。為免誤解，謹在此解釋六天是包括由星期一至星期六下午比賽時間。對於改期賽事，是包括比賽前六天至改期賽事的當日。另外在此清楚解釋“有關草場”是指我們的主隊將會使用作賽的草場。如果主隊在草場‘A’作賽，代表外隊的球員不可再使用草場‘A’，但可以在草場‘B’進行練習或比賽，反之亦然，主要視乎主隊將會使用那一個為作賽的草場。至於改期賽事將會使用那一個草場，取決於草地情況及已訂出的草場開放時間表來作決定。
- 違規事件會轉介執委會處理。
- 執委會有權向重犯者在指定期內暫停不能使用本會的草地滾球場。
